- Population of 48.6 million.
- 14th largest economy in the world and 4th in the EU.
- Providing access to 447 million consumers within the EU.
- Spain is a unique hub for the EMEA Region and Latin America.
- Spanish is the second most widely spoken language in the world.

Magnet for talent

- 2 Spanish executive education business schools rank among the top 10 in the world.
- 41.1% of the population has studied tertiary education.

Quality of life

- Diverse, welcoming and tolerant country.
- Unparalleled of residential and educational opportunities.
- Spain has one of the top National Health Systems in the world.
- Spain provides access to unrivalled heritage, culture and nature sites, being world leader in Biosphere Reserves (53) and ranking fourth in the World Heritage Sites list.
- One of the most visited countries in the world. In 2023, a total of 81.5 million international tourists visited Spain.
- Spain is among the first countries with the highest life expectancy in the world.
- Spain is committed to the environment with its Strategic Health and Environment Plan improving population health.

Access to finance

- Low effective tax rate based on allowances on incentives from investments, employment and R+D+i activities compared to the EU average.
- As member of the EU, potential investors in Spain are eligible to access European aid programs.
- Some Spanish regions provide incentives for investments.
- Up to 42% corporate income tax deduction for research and development activities.
- Spain has one of the most beneficial patent box regimes in the EU: it exempts up to 60% of the net income from the use or exploitation of the intangible assets that are transferred (patents, models, designs, formulas or projects) from taxation.

Innovation Hub

- Spain is a top reference in the fields of transplant and in the research against heart disease, cancer, Alzheimer, malaria and HIV/AIDS.
- Spain is the fifth European aeronautical power.
- Spain ranked 1st in Europe and 2nd in the world, after China, in the number of high-performance kilometers in operation, with 3,402 km of high-speed railway tracks.
- Spain ranks 10th among the countries with the highest investment attractiveness in renewable energies. We are the country with the most active concentrated solar thermal power plants, representing 30% of the world's installed capacity.


